To support safe and efficient operations, please ensure all cargo is declared correctly. Discrepancies between declared and actual cargo may result in additional charges under our Compensation for Breach of Agreement (CBA) process. The new level for charges will be applicable across all trade lanes and services and will be valid until further notice.
